PRESIDENTS REPORT: Talking points.

- 1. General upkeep reminder. Unkempt properties give a lasting first impression. Potentially devaluing properties..
- 2. Feeding of birds and wild animals is prohibited.
- 3. Street seal coating. Statement of work developed for bid solicitation. Preserving streets longevity. Seal cracks or to not seal cracks. Which leads into...
- Street resurfacing (grind and paving) monies being set aside to fund. The est'd cost was 120K, increased to 140k. Our goal as responsible stewards of your association, to avoid a special assessment.
- 5. The Bard AC systems are permanently out of service. Awaiting an estimate for a more cost effective alternate.
- 6. Improving laundry security. One solution being looked at is cipher locks with a 4 digit number. Summer project.
- 7. Showering at the pool We may observe that area with video surveillance
- 8. Sprinklers owners are reminded, sprinklers are association owned and maintained. Please do not remove their components. An inventory of lots in need of new sod will be taken.

Summer reminders

- 9. Speeding Our narrow streets require for the safety of all concerned to obey the speed limit 20 MPH. Owners are asked to remind their tenants and guests.
- 10. Street Parking Street parking even for a brief time, can result in delays of a medical emergency. It makes it difficult for emergency vehicles to navigate our narrow streets.
- 11. When meetings resume in September, a new Census, and a new Pet census will be sent out. As per Pinellas County regulations and laws, all Cats and Dogs are required to be current with mandatory shots.
- 12. Owners are reminded that a second vehicle requires authorization in writing from the owner giving permission to park in a carport or designated parking spot. Authorizations will be on file at the office.
- 13. Owners are reminded that dogs are not permitted to defecate on common areas. Common areas include the grass in front of units, grassy areas between units, alleys, the grassy area along the west wall to the curb.
